
The rates should be quoted against the respective item as detailed below.

02.	Lunch (Rice, Dal, Sabji, Papad, Chutni etc.)	
03.	Evening (Puri/Rooti-Sabji, Chowmin/Roll)	
04.	Dinner (Rice, Dal, Sabji, Brinjal Vatta, Paneer, Papad)	
05.	Drinking water bottle (20 Lts)	

The quotations must fulfill the following terms & conditions.

- 1) Quotation must be clear and should be completed in all respect.
- 2) The rates should clearly be quoted both in figures and words against each item according to their variety.
- 3) The quoted rates must be inclusive of all taxes.
- 4) Bidders should submit income tax clearance certificates, GST registration, Trade license, PAN card etc.


